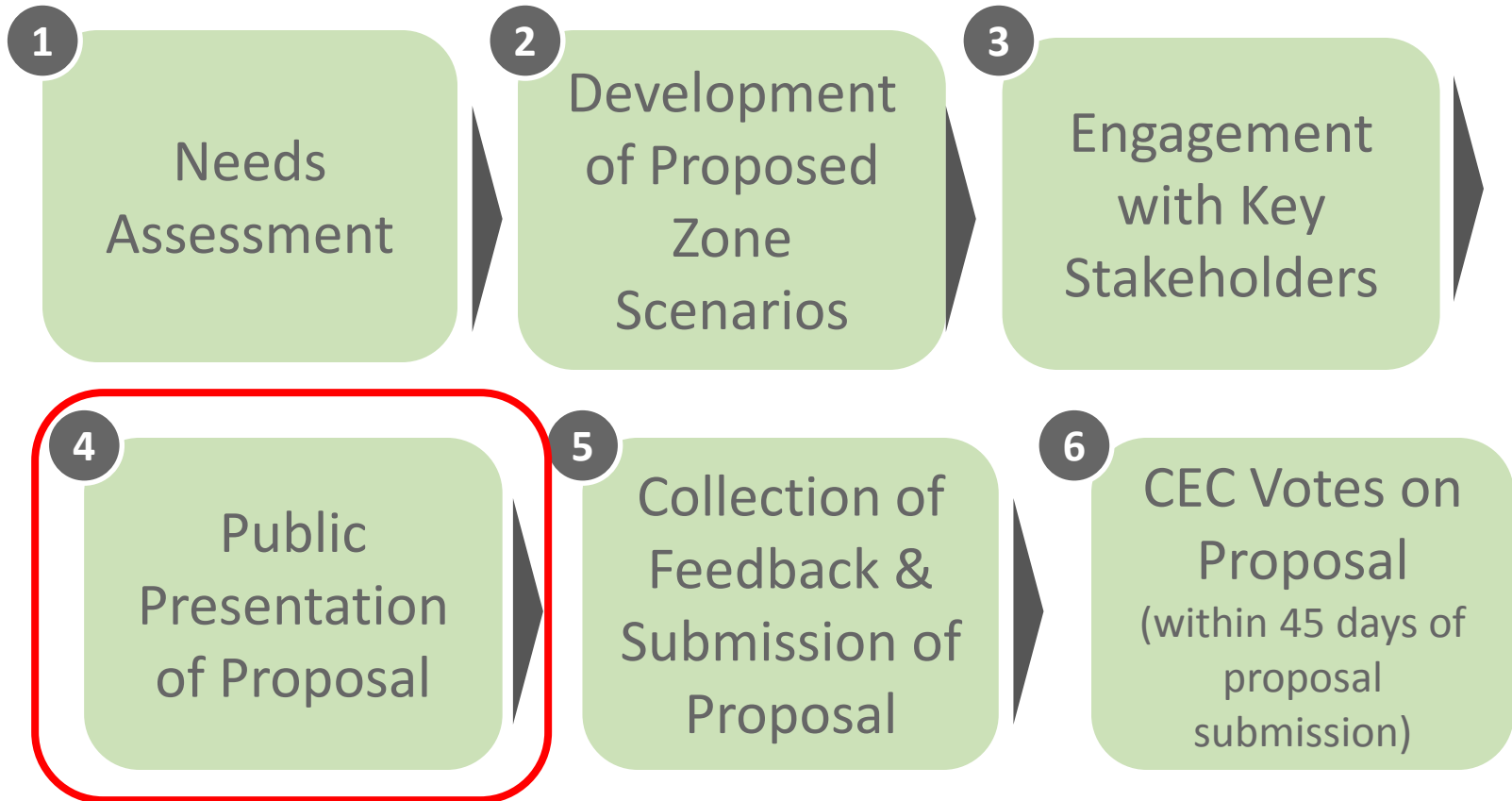
# Rationale for Rezoning

---

- Create appropriate zone sizes for each building's capacity taking future growth into account.
- Allow families to better know and anticipate elementary school options by avoiding waitlists.
- Grow the P.S. 307 zone and enrollment to serve more students.
- Alleviate kindergarten waitlists at P.S. 8, a school that cannot accommodate all students in its zone.

# Methodology – Determining the Target Kindergarten Zone Size

---

## **Seat Supply: What is the capacity of each school?**

Specifically, how many instructional sections (i.e., classes) and how many students can each building accommodate?

The DOE assesses capacity based on:

- Full-size classrooms available in the building
- Cluster rooms and administrative space a school is entitled to per the Citywide Instructional Footprint
- Historical enrollment increases and decreases at each grade level

## Methodology – Determining the Target Kindergarten Zone Size (cont.)

---

### Seat Demand: How many students do we anticipate?

We assess demand – both from inside and outside the zone – based on historical:

- Kindergarten students living in the zone
- Kindergarten waitlists
- Average class sizes
- Zone retention rates (the percent of students who live in the zone and attend their zoned school)
- Zone enrollment rates (the percent of enrolled students who are also zoned to that school)
- Anticipated Kindergarten growth as a result of new residential projects



# Methodology – Determining the Zone Lines

---

- Contains appropriate number of residents for a school's size, based on recent public school enrollment trends
- Factors we take into consideration:
  - New residential construction
  - Diversity
  - Geographic barriers
  - Travel distance

# Planning Overview – Current Landscape

---

## P.S. 8 in K008

- Cannot accommodate all the students in its zone
- Kindergarten waitlist for 2015-2016 school year
- Population residing in current zone is expected to grow significantly

## P.S. 307 and Satellite West Middle School in K307

- Building utilization of 58%<sup>1</sup>
- P.S. 307 has a zone size of only 17 kindergarten students in 2014-2015
- Has excess capacity to accommodate additional zoned elementary students



# Planning Overview ES – Proposed Changes

---

## Rezone P.S. 8 and P.S. 307

- Use capacity in the K307 building to serve additional elementary students
- Grow zone size and enrollment at P.S. 307
- Reduce zone size at P.S. 8

# Planning Overview ES – Outcomes

---

## District 13 Families

- Clear options to inform school choice
- Additional elementary school seats for future District 13 students residing in the area

## P.S. 307 in K307

- More sustainable zone size
- Grow P.S. 307's enrollment

## P.S. 8 in K008

- Alleviate waitlist for zoned students, and families have greater ability to anticipate options

# Growth Plan for P.S. 307 and Benefits of Growth

- Grow zone size to generate a stable and reliable enrollment
- Grow P.S. 307's enrollment to provide an additional 360 elementary seats to the District
- Funding follows students and higher enrollment allows for more programming
- Increase access to P.S. 307's unique programs, which include Mandarin, chess, violin, ASD Horizon, and pre-kindergarten
- New staff and teachers will be hired as more classes are added to the school consistent with enrollment needs



# Planning Overview MS – Proposed Changes

---

## Re-Site Satellite West Middle School to New Building K611

- Allow Satellite West to grow and make use of new middle school space opening at K611 in September 2016
- Redesign Satellite West in K611 to offer middle school option aligned to vision articulated by District 13 residents
- Timeline for Proposal

# Planning Overview MS – Outcomes

---

## Satellite West Middle School in K611

- Offers 333 redesigned middle school seats in K611
- Gives D13 community access to new MS facilities

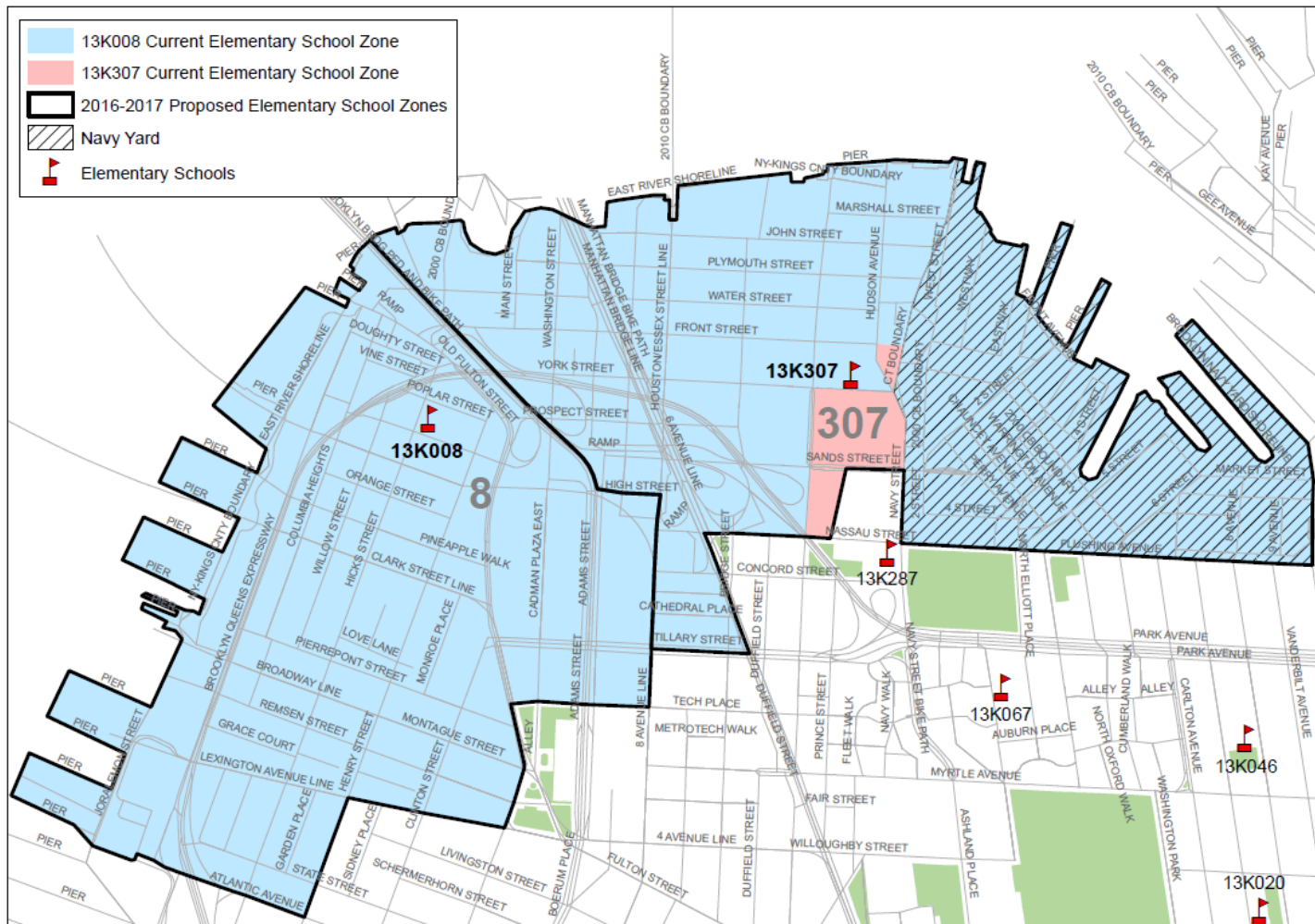

This rezoning proposal will allow P.S. 8's enrollment to remain stable across grades and for the school to better accommodate zoned students.

# Appendix A.1 – Admissions Process<sup>1</sup> - Pre-Kindergarten

1. Students residing in the zone, who have a sibling pre-registered or enrolled at the time of application submission and will be enrolled in grades K-5 in the school at the start of the following school year.<sup>1</sup>
2. Students residing in the zone, who do not have a sibling at the school.<sup>1</sup>
3. Students residing in the district, who have a sibling at the school,
  - a. who have no zoned school or whose zoned school has no pre-K program, then
  - b. who are zoned to a different school which has a pre-K program.
4. Students residing in the borough, who have a sibling at the school.
5. Students residing out-of-borough, who have a sibling at the school.
6. Students residing in the district,
  - a. who have no zoned school or whose zoned school has no pre-K program, then
  - b. who are zoned to a different school which has a pre-K program.
7. Students residing in the borough.
8. Students residing out-of-borough.



# Appendix A.2 – Admissions Process<sup>1</sup> - Kindergarten

Students will be enrolled in New York City elementary schools by the following priority:

1. Zoned students whose verified siblings are pre-registered or enrolled at the time of application submission and will be enrolled in grades K-5 in the school at the start of the following school year
2. Zoned students other than those in (1) above applying to the zoned school
3. Students whose verified siblings are pre-registered or enrolled at the time of application submission and will be enrolled in grades K-5 in the school at the start of the following school year who are not zoned to the school,
  - a. Within District first, then
  - b. Out of District
4. Students currently attending the school's pre-kindergarten program who reside outside the school's zone, *without* a sibling who will be in grades K-5 at the school in the following school year,
  - a. Within District first, then
  - b. Out of District
5. Students other than those in (3a) and (4a) above who are residents of that district
6. Students other than those in (3b) and (4b) who are residents of another district
